**WHEREAS**, the South Las Posas Basin is in hydrologic continuity with the East Las Posas Basin and Simi Valley Basin; and

**WHEREAS**, the shallow groundwater quality in the South Las Posas Basin is only marginally useable for domestic and agricultural purposes; and

**WHEREAS**, the water levels the South Las Posas Basin are sufficiently high to encroach upon better quality water in the downgradient East Las Posas Basin; and

**WHEREAS**, the groundwater in the South Las Posas Basin could be made into a useable source of water through several presently available means; and

**WHEREAS**, the extraction of the South Las Posas groundwater can provide an additional source of useable water as well as mitigate potential impacts to the East Las Posas Basin so it should be available to all potential users.

**THEREFORE, IT IS HEREBY PROCLAIMED AND ORDERED** that upon the review and approval by the Fox Canyon Groundwater Management Agency, an allocation for pumping from the South Las Posas Basin may be changed or altered to accommodate a responsible entity that submits a plan to render this groundwater usable.
