**WHEREAS**, the Fox Canyon Groundwater Management Agency desires to change the groundwater extraction charge for those extraction facilities located within the boundary of the Fox Canyon Management Agency; and;


**WHEREAS**, the groundwater extraction charge now in effect does not provide the funding necessary to carry on the regular duties of the Fox Canyon Management Agency, and;

**WHEREAS**, Deering's Water Uncodified Acts, Act 2670, Section 10 as amended, grants the Board of Directors of the Fox Canyon Groundwater Management Agency the authority to levy groundwater extraction charges up to three dollars (\$3.00) per acre foot pumped per year.

**NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND ORDERED** that effective July 1, 1993, and until January 1, 1994, the groundwater extraction charge shall be three dollars (\$3.00) per acre foot pumped from facilities within the boundaries of the Fox Canyon Groundwater Management Agency.

**IT IS FURTHER PROCLAIMED AND ORDERED** that effective January 1, 1994, the groundwater extraction charge shall be two dollars and twenty cents (\$2.20) per acre foot pumped per year from facilities within the boundaries of the Fox Canyon Groundwater Management Agency.


On motion by Director Daniels, seconded by Director Conroy, the foregoing resolution was passed and adopted on June 30, 1993.

**A RESOLUTION**

**INCREASING EXTRACTION CHARGES TO  
\$3.00 PER ACRE-FOOT**

**IT IS FURTHER PROCLAIMED AND ORDERED that effective January 1, 1994, the groundwater extraction charge shall be two dollars and twenty cents (\$2.20) per acre-foot pumped per year from facilities within the boundaries of the Fox Canyon Groundwater Management Agency.**
